



### Updates to mandatory documents on ApplyOnline

We've recently updated AOL and removed the need for you to complete and upload the customer 'Privacy Declaration Form' on AOL. Customer Privacy Declaration will now be captured as part of the 'Acknowledgements, Confirmations & Consents' form (ACC).

Please note that updates to AOL can take up to 2 weeks. During this period, AOL may still require you to upload the now removed Privacy Declaration Form. If this occurs, please select both the ACC and Privacy Declaration tick boxes when uploading the ACC form in the 'Supporting Documents' tab (refer to the screenshot below).
