At BankSA, we're keeping you up to date with the latest changes to our interest rates, including:

- An increase to our variable home loan interest rates.

Rate changes.

Following the Reserve Bank of Australia's decision to increase the official cash rate in February, BankSA announced it will increase variable home loan interest rates by 0.25% per annum (p.a.).

The following interest rate changes will come into effect on **21 February 2023** for new and existing home loan variable rate products:
