### **Interest Rate Update**

In response to the challenges of increased costs of funding we are making a minor adjustment to our <75% LVR Owner Occupied variable home loan interest rates for new to bank lending.

An increase to these rates will be effective from Wednesday 29th March, 2023.

#### What is Changing?

#### **Increase in Rates for New Owner Occupied Lending**

 Owner Occupied Variable rate loans with LVR tier below or equal to 75% – increasing by 0.04

#### What is Not Changing?

- Variable rate pricing for all new Investment Home Loans.
- Variable rate pricing for new Owner Occupied Home Loans above 75% LVR.
- Fixed rate pricing for new home loans.
- Fixed rate pricing for existing home loans.
- Investor 0.20% Bonus Rate Discount Campaign will continue to be available. See our Broker Website for full details or speak to your BRM.

- 2. Applications received prior to midnight 28th March 2023, but not yet approved (does not include pre-approvals):
  - **FIXED** (No change)
  - **VARIABLE** (Rates Increasing) Interest Rate will be the new interest rate applicable on the 29th March, 2023.
- 3. Applications Approved (includes loan approved prior to midnight 28th March, 2023 documented or not documented):
  - **FIXED** (No changes)
  - **VARIABLE** (Rates Increasing) For applications that have been documented the increase of 0.04% will not be applied.
- 4. Loan Applications that have settled:
  - **FIXED** (no change) There is no impact to loans that have settled.
  - VARIABLE There is no impact to loans that have settled.
