More support for customers looking to refinance to Connective Home Loans Essentials

With refinancing high on the agenda for many homeowners, from **21 July 2023** we will be refreshing our existing approach to help support eligible refinance customers switch to Connective Home Loans Essentials who are considered a good credit risk, but may not fully meet standard lending criteria including serviceability buffers.

A case-by-case approach

We recognise each customer is different, which is why we'll begin taking a 'case by case' approach when assessing serviceability on refinance applications, provided the customer:

- Has a Principal and Interest loan;
- Has > 20% equity in their home;
- Is looking to refinance the same amount (and cover any bank related fees up to 1% of the loan value);
- Will require the loan for the same term or the loan term can be extended where appropriate; and
- Has a good repayment history on their current loan.

A specialised team of customer service experts has been created to support customers who meet the above criteria with this process.

There will be no change in process for refinance applications which do not meet the above criteria.

Advantedge standard terms and conditions will continue to apply.
