Updates to auto redaction of TFNs on ApplyOnline

It is an Advantagedge requirement that all customer Tax File Numbers (TFN) are redacted from documentation prior to submission.

Currently, when a document is uploaded to a condition card, you will be alerted about a possible TFN in the document by displaying a yellow warning message against the condition card.

The redaction tool within ApplyOnline has been enhanced to speed up the TFN redaction process. The tool will highlight the possible TFN detected within the attached document, making it easier for you to review and automatically redact the TFNs with a click of a button.

The following features have been introduced:

- Total TFN count displayed on both single and multiple documents
- TFN suggestions highlighted on the document for immediate review
- Automatic redaction with a single click on the newly designed toolbar
- Ability to Dismiss TFN suggestions
- Ability to undo redactions or dismissals

Note: There is no change to the existing toolbar feature which will still be available should the tool not correctly detect the TFN.
