

More businesses now eligible for lending via SIMPLE+

Our SIMPLE+ business lending submission pathway can now be used for Business lending requests up to **\$3M** (previously \$1.5M) – allowing more customers to access our faster, simpler and easier lending pathway. Some key features of SIMPLE+ are:

- Up to \$500K overdraft or business loan with no requirement for property as security
- Extended LVRs available against residential and commercial security in line with policy, even for property investment
- Simplified assessment criteria for residential and commercial property investors ineligible for Lease Doc
- Borrowing structures with up to 4 business entities and 4 households.

Please refer to the updated SIMPLE+ broker flyer for further information but note the eligibility and documentation requirements remain unchanged.
