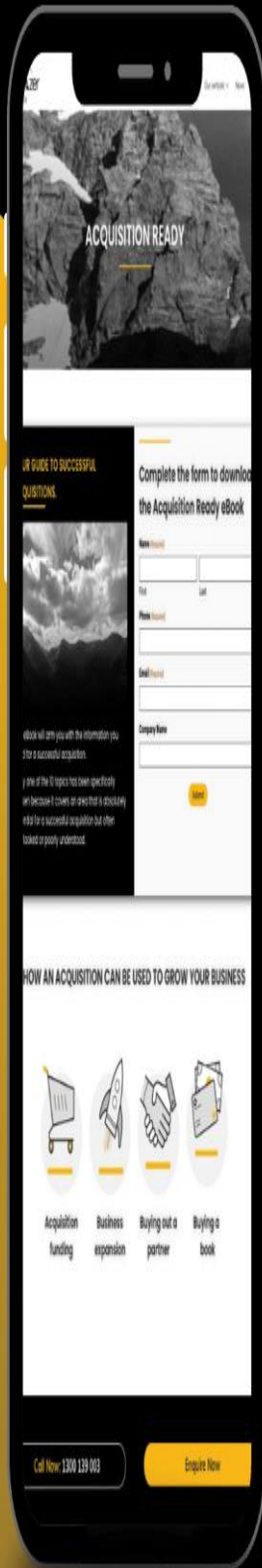

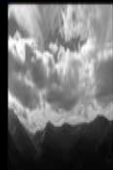

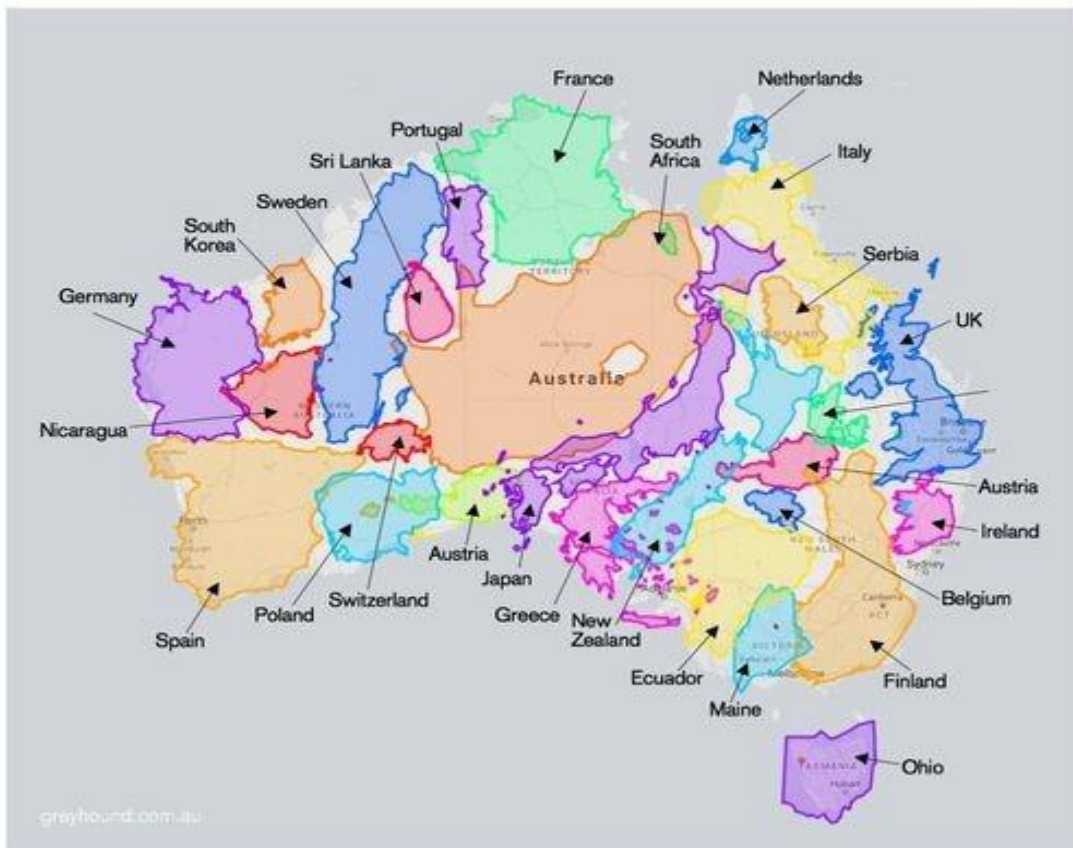
## Cycling for a Cause
